In ADDITION, the undersigned AGREES TO INDEMNIFY AND HOLD HARMLESS the releases from any loss, liability, damage or cost they incur to such participation by the undersigned and any passengers (including minors) whether caused by releases negligence or otherwise, and AGRESS TO ASSUME FULL RESPONSIBILITY AND RISK for any bodily injury, death, or property damage from releases negligence or otherwise while the undersigned is participating at this event. - To participate on the obstacle course your JEEP tire size should not exceed 40” and a combined lift shall not exceed 6”
- That all occupants shall at all times while riding in a vehicle participating in this event, Wear his or her respective seat belts.
- That the owner/driver certifies that he or she has inspected this vehicle and same as in good mechanical condition.
- All occupants of the vehicle will be registered.
- Vehicle has a valid proof of insurance and current vehicle registration.
- No firearms, fireworks or sirens on or in vehicle.
- There will be at least one person 18 years or older who will be responsible for occupants of the vehicle.
- Vehicle is equipped with tow points attached to the frame.
- No occupants of the vehicle will possess or consume alcohol while on the trails or obstacles. Doing so means immediate expulsion.
- That he or she has read the foregoing Release and Waiver Liability and Indemnity Agreement and understands that he or she is assuming liability and indemnifying releases from any damages or injury.
- South Creek Jeep Daze, their sponsors and guides cannot be held responsible for any damage that may occur to the vehicle while attending the South Creek Jeep Daze.
- Violation of these rules will result in the termination of all participants’ participation in the Jeep Daze and the forfeiture of all registration fees.
- We agree to abide by the rules, guidance and instruction of the South Creek Jeep Daze.
